To Whom It May Concern:

May 20, 2010

In the event of a natural disaster (flood, tornado, hurricane, earthquake, power outage, etc.) FastCo Food Services of the Triad will provide or arrange for the provision of food and food related products (including bottled drinking water) to BLUERIDGE ASSISTED LIVING FACILITIES at the customary charge. Further, should the facility be disabled and incapable of storing food products, FastCo Food Services of Greensboro will arrange for storage via trailer to offer frozen, refrigerated and dry storage. It will be the responsibility of BLUERIDGE ASSISTED LIVING FACILITIES to provide a full-time security system for this property for the duration of the service. BLUERIDGE ASSISTED LIVING FACILITIES, prior to placement of the trailer, will provide a certificate of insurance for liability coverage on the trailer.

BLUERIDGE ASSISTED LIVING FACILITIES agrees to pay a reasonable fee to FastCo Food Services of Greensboro for services rendered.
